A BILL

To amend title 18, United States Code, to prohibit foreign nationals from making contributions in connection with a State or local ballot initiative or referendum.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Keeping Foreign
- 5 Money out of Ballot Measures Act of 2023".

1	SEC. 2. PROHIBITION ON CONTRIBUTIONS AND DONATIONS
2	BY FOREIGN NATIONALS IN CONNECTION
3	WITH BALLOT INITIATIVES AND REFERENDA.
4	(a) In General.—Chapter 29 of title 18, United
5	States Code, is amended by adding at the end the fol-
6	lowing new section:
7	"§ 612. Foreign nationals making certain political

9	"(a) Prohibition.—It shall be unlawful for a for-
10	eign national, directly or indirectly, to make a contribution
11	as such term is defined in section $301(8)(A)$ of the Federal
12	Election Campaign Act of 1971 (52 U.S.C. 30101(8)(A))
13	or donation of money or other thing of value, or to make
14	an express or implied promise to make a contribution or
15	donation, in connection with a State or local ballot initia-
16	tive or referendum.
17	"(b) Penalty.—Any person who violates subsection
18	(a) shall be fined not more than the greater of \$10,000
19	or 300 percent of the amount of the contribution or value
