**A BILL**

To establish the Mental Health in Schools Excellence Program to increase the recruitment and retention of school-based mental health services providers, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Mental Health in  
5       Schools Excellence Program Act of 2025”.

1   **SEC. 2. PROGRAM TO ESTABLISH PUBLIC-PRIVATE CON-**  
2                   **TRIBUTIONS TO INCREASE THE AVAILABLE**  
3                   **WORKFORCE OF SCHOOL-BASED MENTAL**  
4                   **HEALTH SERVICE PROVIDERS.**

5       (a) PROGRAM AUTHORIZED.—The Secretary shall  
6 carry out a program under which eligible graduate institu-  
7 tions may enter into an agreement with the Secretary to  
8 cover a portion of the cost of attendance of a participating  
9 student, which contributions shall be matched by equiva-  
10 lent contributions towards such cost of attendance by the  
11 Secretary.

12       (b) DESIGNATION OF PROGRAM.—The program  
13 under this section shall be known as the “Mental Health  
14 in Schools Excellence Program”.

15       (c) AGREEMENTS.—The Secretary shall enter into an  
16 agreement with each eligible graduate institution seeking  
17 to participate in the program under this section. Each  
18 agreement shall specify the following:

19           (1) The manner (whether by direct grant, schol-  
20 arship, or otherwise) in which the eligible graduate  
21 institution will contribute to the cost of attendance  
22 of a participating student.

23           (2) The maximum amount of the contribution  
24 to be made by the eligible graduate institution with  
25 respect to any particular participating student in  
26 any given academic year.

1           (3) The maximum number of individuals for  
2           whom the eligible graduate institution will make con-  
3           tributions in any given academic year.

4           (4) That the eligible graduate institution, in se-  
5           lecting participating students to receive assistance  
6           under the program, shall prioritize the participating  
7           students described in subsection (d)(2).

8           (5) Such other matters as the Secretary and  
9           the eligible graduate institution determine appro-  
10          priate.

11         (d) OUTREACH.—The Secretary shall—

12           (1) make publicly available and periodically up-  
13           date on the internet website of the Department of  
14           Education a list of the eligible graduate institutions  
15           participating in the program under this section that  
16           shall specify, for each such graduate institution, ap-  
17           propriate information on the agreement between the  
18           Secretary and such college or university under sub-  
19           section (c); and

20           (2) conduct outreach about the program under  
21           this section to participating students who, as under-  
22           graduates—

23                 (A) received a Federal Pell Grant under  
24                 section 401 of the Higher Education Act of  
25                 1965 (20 U.S.C. 1070a); or

1 (B) attended an institution listed in section  
2 371(a) of the Higher Education Act of 1965  
3 (20 U.S.C. 1067q(a)).

4 (e) MATCHING CONTRIBUTIONS.—The Secretary may  
5 provide a contribution of up to 50 percent of the cost of  
6 attendance of a participating student if the eligible grad-  
7 uate institution at which such student is enrolled enters  
8 into an agreement under subsection (c) with the Secretary  
9 to match such contribution.

10 **SEC. 3. DEFINITIONS.**

11 In this Act:

12 (1) COST OF ATTENDANCE.—The term “cost of  
13 attendance” has the meaning given the term in sec-  
14 tion 472 of the Higher Education Act of 1965 (20  
15 U.S.C. 1087ll).

16 (2) ELIGIBLE GRADUATE INSTITUTION.—The  
17 term “eligible graduate institution” means an insti-  
18 tution of higher education in that offers a program  
19 of study that leads to a graduate degree—

20 (A) in school psychology that is accredited  
21 or approved by the National Association of  
22 School Psychologists’ Program Accreditation  
23 Board or the Commission on Accreditation of  
24 the American Psychological Association and  
25 that prepares students in such program for the

1 State licensing or certification examination in  
2 school psychology at the specialist level;

3 (B) in an accredited school counseling pro-  
4 gram that prepares students in such program  
5 for the State licensing or certification examina-  
6 tion in school counseling;

7 (C) in school social work that is accredited  
8 by the Council on Social Work Education and  
9 that prepares students in such program for the  
10 State licensing or certification examination in  
11 school social work;

12 (D) in another school-based mental health  
13 field that prepares students in such program  
14 for the State licensing or certification examina-  
15 tion in such field, if applicable; or

16 (E) in any combination of study described  
17 in subparagraphs (A) through (D).

18 (3) INSTITUTION OF HIGHER EDUCATION.—The  
19 term “institution of higher education” has the  
20 meaning given such term in section 101 of the High-  
21 er Education Act of 1965 (20 U.S.C. 1001), but ex-  
22 cludes any institution of higher education described  
23 in section 102(a)(1)(C) of such Act.

24 (4) PARTICIPATING STUDENT.—The term “par-  
25 ticipating student” means an individual who is en-

1 rolled in a graduate degree program in a school-  
2 based mental health field at a participating eligible  
3 graduate institution.

4 (5) SCHOOL-BASED MENTAL HEALTH FIELD.—  
5 The term “school-based mental health field” means  
6 each of the following fields:

7 (A) School counseling.

8 (B) School social work.

9 (C) School psychology.

10 (D) Any other field of study that leads to  
11 employment as a school-based mental health  
12 services provider, as determined by the Sec-  
13 retary.

14 (6) SCHOOL-BASED MENTAL HEALTH SERVICES  
15 PROVIDER.—The term “school-based mental health  
16 services provider” has the meaning given the term in  
17 section 4102 of the Elementary and Secondary Edu-  
18 cation Act of 1965 (20 U.S.C. 7112).

19 (7) SECRETARY.—The term “Secretary” means  
20 the Secretary of Education.
