Mr. FITZPATRICK introduced the following bill; which was referred to the Committee on _____

A BILL

To prohibit immediate family members of heads of certain agencies and departments from soliciting or otherwise raising funds from certain foreign entities.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Cabinet Service Integ-

5 rity Act”.

6 **SEC. 2. DEFINITIONS.**

7 In this Act:

1 (1) CLOSE ASSOCIATE.—The term “close asso-
2 ciate” means, with respect to a senior foreign polit-
3 ical figure, an individual who is widely and publicly
4 known to maintain a close relationship with the sen-
5 ior foreign political figure, unless it is established
6 that such individual is a citizen of and domiciled
7 within the United States.

8 (2) COVERED FOREIGN ENTITY.—The term
9 “covered foreign entity” means—

10 (A) a government of a foreign country;

11 (B) a foreign political party; or

12 (C) any entity that is owned or controlled
13 by a government of a foreign country or a for-
14 eign political party.

15 (3) FOREIGN POLITICAL PARTY; GOVERNMENT
16 OF A FOREIGN COUNTRY.—The terms “foreign polit-
17 ical party” and “government of a foreign country”
18 have the meanings given those terms in section 1 of
19 the Foreign Agents Registration Act of 1938 (22
20 U.S.C. 611).

21 (4) IMMEDIATE FAMILY MEMBER OF A HEAD
22 OF A RELEVANT AGENCY OR DEPARTMENT.—The
23 term “immediate family member of a head of a rel-
24 evant agency or department” means, with respect to
25 a head of a relevant agency or department, a sibling,

1 spouse, or child of the head of a relevant agency or
2 department.

3 (5) IMMEDIATE FAMILY MEMBER OF A SENIOR
4 FOREIGN POLITICAL FIGURE.—The term “immediate
5 family member of a senior foreign political figure”
6 means, with respect to a senior foreign political fig-
7 ure, a sibling, spouse, or child of the senior foreign
8 political figure, unless it is established that such sib-
9 ling, spouse, or child is a citizen of and domiciled
10 within the United States.

11 (6) RELEVANT AGENCY OR DEPARTMENT.—The
12 term “relevant agency or department” means—

13 (A) the Environmental Protection Agency;

14 or

15 (B) an “Executive department”, as defined
16 in section 101 of title 5, United States Code.

17 (7) SENIOR FOREIGN POLITICAL FIGURE.—The
18 term “senior foreign political figure” means—

19 (A) a senior official in any branch of the
20 government of a foreign country; or

21 (B) a senior official of a foreign political
22 party.

23 **SEC. 3. PROHIBITION.**

24 During the period in which an individual is acting
25 as the head of a relevant agency or department, an imme-

1 diate family member of that head of a relevant agency or
2 department may not solicit or otherwise raise funds for
3 any purpose from any—

4 (1) covered foreign entity;

5 (2) senior foreign political figure;

6 (3) immediate family member of a senior for-
7 eign political figure;

8 (4) close associate of a senior foreign political
9 figure; or

10 (5) entity that is owned or controlled by an in-
11 dividual described in paragraph (2), (3), or (4).

12 **SEC. 4. PENALTIES.**

13 Whoever knowingly fails to comply with this Act shall
14 be fined not more than \$1,000,000, imprisoned not more
15 than 5 years, or both.

16 **SEC. 5. EFFECTIVE DATE.**

17 This Act shall take effect on the date that is 30 days
18 after the date of enactment of this Act.
