A BILL

To amend the Animal Welfare Act to provide for the humane treatment of dogs, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Puppy Protection Act
- 5 of 2023".
- 6 SEC. 2. ADDITIONAL REQUIREMENTS FOR DEALERS.
- 7 (a) Humane Treatment of Dogs by Dealers.—
- 8 Section 13(a) of The Animal Welfare Act (7 U.S.C.

1	2143(a)) is amended by adding at the end the following
2	new paragraph:
3	"(9) In addition to the requirements under paragraph
4	(2), the standards described in paragraph (1) shall, with
5	respect to dealers, include requirements—
6	"(A) that such dealer provide adequate housing
7	for dogs that includes—
8	"(i) completely solid flooring;
9	"(ii) indoor space sufficient to allow the
10	tallest dog in an enclosure to stand on his or
11	her hind legs without touching the roof of the
12	enclosure;
13	"(iii) with respect to dogs over 8 weeks in
14	age, primary enclosures that, with the length of
15	the dog measured from the tip of the nose to
16	the base of the tail, provide at least—
17	"(I) 12 square feet of indoor floor
18	space per each dog up to 25 inches long;
19	"(II) 20 square feet of indoor floor
20	space per each dog between 25 and 35
21	inches long; and
22	"(III) 30 square feet of indoor floor
23	space per each dog 35 inches and longer;

1	"(iv) enclosures that are not stacked or
2	otherwise placed on top of or below another en-
3	closure; and
4	"(v) temperature control that—
5	"(I) is appropriate for the age, breed,
6	and condition of the dogs in the enclosure;
7	and
8	"(II) is between 45 and 85 degrees
9	Fahrenheit, when dogs are present in the
10	enclosure;
11	"(B) that appropriate and nutritious food be
12	provided to each dog at least twice per day, in an
13	amount sufficient to maintain the good health and
14	physical condition of each such dog;
15	"(C) that each dog has continuous access to po-
16	table water that is not frozen and is free of feces,
17	algae, and other contaminants;
18	"(D) that each dog has adequate exercise, in-
19	cluding—
20	"(i) for dogs over the age of 12 weeks, un-
21	restricted access from their primary enclosures
22	during daylight hours to an outdoor exercise
23	area that is—
24	"(I) at ground-level;
25	"(II) a solid surface;

1	"(III) enclosed (by a fence or other
2	structure);
3	"(IV) properly controlled for the safe-
4	ty of the dogs; and
5	"(V) allows the dog to extend to full
6	stride, play, and engage in other types of
7	mentally stimulating and social behaviors;
8	or
9	"(ii) if the dealer obtains a certification
10	from the attending veterinarian stating that the
11	dog should not have unfettered access to an
12	outdoor exercise area for a specific medical rea-
13	son, an alternative exercise plan prescribed by
14	the veterinarian for the dog that meets the re-
15	quirements under section 3.8a of title 9, Code
16	of Federal Regulations;
17	"(E) that each dog has meaningful socialization
18	with humans and compatible dogs for at least 30
19	minutes each day that—
20	"(i) includes positive interaction with a
21	human such as petting, stroking, grooming,
22	feeding, playing with, exercising, or other
23	touching of the dog that is beneficial to the
24	well-being of the dog; and

1	"(ii) does not include time spent in veteri-
2	nary care;
3	"(F) that each dog receives adequate veterinary
4	care, including—
5	"(i) prompt treatment of any disease, ill-
6	ness or injury by a licensed veterinarian;
7	"(ii) a thorough hands-on examination by
8	a licensed veterinarian at least once each year,
9	which shall include a dental exam;
10	"(iii) core vaccinations recommended by
11	the current version of the American Animal
12	Hospital Association Canine Vaccination Guide-
13	lines; and
14	"(iv) medications to prevent intestinal
15	parasites, heartworm disease, fleas, and ticks
16	that are approved by a licensed veterinarian for
17	canine use;
18	"(G) with respect to safe breeding practices for
19	dogs, including—
20	"(i) a screening program for known preva-
21	lent inheritable diseases that may be disabling
22	or likely to significantly affect the lifespan or
23	quality of life of the mother or her offspring;
24	"(ii) prohibiting breeding, unless each dog
25	bred has been screened by a veterinarian prior

1	to each attempt to breed and is found to be free
2	from health conditions that may be disabling to,
3	or likely to significantly affect the lifespan or
4	quality of life of, the mother or her offspring
5	(as documented by a licensed veterinarian upon
6	examination);
7	"(iii) prohibiting the breeding of a female
8	dog —
9	"(I) to produce more than two litters
10	in any 18-month period; or
11	"(II) more than 6 litters in that dog's
12	lifetime;
13	"(iv) that female dogs of small breeds
14	(having a maximum weight range at maturity
15	that is below 40 pounds) not be bred—
16	"(I) before reaching the age of 18
17	months; or
18	"(II) after reaching the age of 9
19	years;
20	"(v) that female dogs of large breeds (hav-
21	ing expected weight ranges at maturity that in-
22	clude 40 or more pounds) not be bred—
23	"(I) before reaching the age of 2
24	years; or

1	"(II) after reaching the age of 7
2	years; and
3	"(vi) that any canine caesarian section be
4	performed by a licensed veterinarian;
5	"(H) that dogs be housed with other dogs, un-
6	less health or behavioral issues make group housing
7	unsafe; and
8	"(I) to make all reasonable efforts to find hu-
9	mane placement for retired breeding dogs (such as
10	with an adoptive family, rescue organization, or
11	other appropriate owner for that dog, and not in-
12	cluding selling at auction or otherwise placing a re-
13	tired breeding dog with another breeder for breeding
14	purposes).".
15	(b) Conforming Amendment.—Section
16	13(a)(2)(B) of the Animal Welfare Act (7 U.S.C.
17	2143(a)(2)(B)) is amended by inserting "subject to para-
18	graph (9)," before "for exercise of dogs".
19	SEC. 3. REGULATIONS.
20	Not later than 18 months after the date of the enact-
21	ment of this Act, the Secretary shall issue final regulations
22	establishing the standards for the care of dogs by dealers,
23	as required by this Act.
